

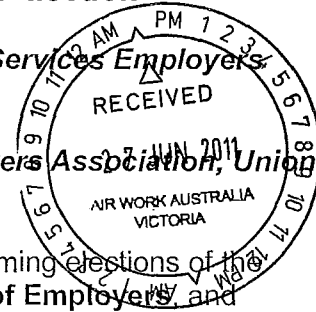

- For offices to be elected by direct voting system – (twelve) 12 noon on 21<sup>st</sup> day after sending the notice of nomination.

**Cut-off date for roll:**

- In all cases – 30 days prior to the opening date for nominations – rule (27)
