The National Entity account had ceased to operate and indeed a request for exemption for reporting units was requested and granted for the financial years ending 30 June 2009, 30 June 2010, 30 June 2011, 30 June 2012, 30 June 2013, 30 June 2014, 30 June 2015, 30 June 2016, 30 June 2017, 30 June 2018, 30 June 2019 and 30 June 2020.

The reporting unit did not maintain a bank account.

The reporting unit did not hold money in cash.

The reporting unit did not receive revenue during the financial year.

The reporting unit did not expend any money during the financial year.

The reporting unit did not incur any liabilities during the financial year.

No other reporting units receive money or incur financial obligations so that the applicant reporting unit could conduct its activities.
