## About the AAA

**Organisation type and coverage:** an organisation of employers connected to the industry of motor inns, private hotels, serviced apartments, holiday accommodation and caravan parks

**Financial year:** 1 July to 30 June

**Date of registration:** 5 February 1971

The supreme governing authority of the organisation is vested in the National Federal Council, which comprises the Office Bearers, delegates from branches and established sections. The organisation is also governed by a Federal Executive and a Federal Management Committee. The branches are each governed by a Branch Council.

The organisation is a reporting unit for the purposes of filing a financial report.

Under the rules of the organisation, elections for offices are conducted every 3 years.
