The organisation presents 1 financial report, which incorporates the financial affairs of the head office and all of the branches on the basis of a consolidation certificate issued on 26 November 1984.

The organisation is governed by the Federal Council. The branches are represented on the Federal Council by their respective Secretaries and other ordinary members. Its elections are conducted by the AEC.
