Arrangement for conduct of election.

[1] On 5 April 2017 the Victorian Showmen's Guild (the organisation) lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices:

- President
- Secretary
- Treasurer
- Trustees (2)
- Committee Members (19, of which 10 will be Vice-Presidents as discussed below)

[2] The organisation has also requested an election be conducted for the office of Vice-President. In accordance with rules 16.4.1 and 16.7 of the organisation's rules, the 10 candidates receiving the highest number of votes shall be declared elected to the office of Vice-President. The next nine candidates receiving the highest number of votes shall be declared elect to the office of Committee Member.

[3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
